## Eligibility requirements

To qualify for our services, the patient must be:

- Essentially homebound. The patient does not need to be bedridden but must require assistance to leave the home.
- Needing intermittent care

## Who Pays?

Medicare covers home health services. Our team can help you find out if other private insurance policies will cover your home healthcare and/or whether the patient will have any financial responsibility.

## STNA/HHA Training

As part of our learning enhancement program, we conduct classes to individuals who would want to become STNA's/CNA's and HHA's.

Our training program is per The State of Ohio Training and Competency Evaluation Program Curriculum Standards. It requires 75 or more hours of training including clinical.

The following are the requirements for our STNA/HHA programs:

- Reliable, dependable and mature
- Valid Ohio Driver's License or State ID
- Ability to lift 25 lbs
- Should be able to read and write
- You must be 17 years or older
- 2-step Mantoux ( TB test ) must be complete before the first day of the class
- Fees should be paid in full before class begins
- Students may require back ground check for clinical purposes
- Passing grade for the training program is 80%
